It has come to our attention that you may be a possible candidate for our hospital's **Financial Assistance Program**. Please read the following information carefully to determine whether or not you would be interested in applying for this program.

Financial Assistance will be considered for patients whose income meets the program criteria. A patient may qualify for a discount on their Summit Healthcare Regional Medical Center account(s) only.

Applicants must apply for and obtain a written approval/denial and income verification from the Arizona State AHCCCS program. You must also be able to provide proof of income for the last three months as well as a copy of your last year's tax return (1040), showing the gross amount of your annual income. Once this information is received by the Business Office of Summit Healthcare Regional Medical Center, the application will be reviewed for qualification for the **Financial Assistance Program** and the applicant will be notified either by mail or phone as to the decision made.

Adjustments to hospital accounts will be made to those applicants who:

- Do not meet AHCCCS eligibility guidelines, but are within the Financial Assistance Program Guidelines.
- Are approved for AHCCCS but not in time to cover previous dates of service.

Please include the following with this application:

1. Your AHCCCS approval/denial letter
2. Your proof of income for the last three months
3. A copy of your last year's tax return.
